SGRC is mandated to consider and address the grievances of the students by following the principles of natural justice. The SGRC shall be required to send its report with its recommendations, if any, to the Hon'ble Vice Chancellor and a copy thereof to the aggrieved student preferably within 15 working days from the date of receipt of the complaint. The tenure of the committee members is up to 22.08.2026. Further, the term of the special invitee shall be one year. The quorum for meetings, including the chairperson but excluding the special invitee, shall be three.

Any student who is dissatisfied with the decision of the Students' Grievance Redressal Committee (SGRC) may prefer an appeal to the Ombudsmen within a period of 15 days from the date of receipt of such decision.
