**A. Eligibility Conditions:**

Details of qualifications and experience etc., for the posts shall be as per the UGC Regulations on Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education 2018, as amended from time to time, and as per other various provisions/notifications provided by UGC. Further, the UGC notification No.F.25-1/2018(PS/MISC.) dated 28<sup>th</sup> January, 2019 and No. F.9-1/2010(PS/MISC) Pt. Vol. I, dated 11<sup>th</sup> October, 2021 may also be referred to.

**B. Honorarium:**

The honorarium for the Guest faculty shall be ₹1,500/- per lecture subject to a maximum of ₹50,000/- per month as per UGC notification No.F.25-/2018(PS/MISC.) dated 28<sup>th</sup> January, 2019.

**C. Nature of Post:**

The guest faculty are purely on daily basis to teach subject on hourly basis, however their performance shall be reviewed periodically. Further their service may be extendable by another semester if university is needed.

**D. General Instructions:**

1. Before applying for a post, applicants are advised to go through the relevant UGC norms/regulations as amended from time to time and as applicable, as well as contents of the advertisement carefully and satisfy themselves about their eligibility. No enquiry in this regard will be entertained.
2. The candidates should submit the CV consisting of the following details:
  - A. Scanned copy of photograph.
  - B. Personal Information (Name, Aadhar number, mobile number, email, date of birth, reservation category (GENERAL/SC/ST/OBC/EWS/PwBD), religion, gender, marital status, permanent address and postal address)

  - D. Research publications and paper presentation in conference.
  - E. Teaching and Research Experience
  - F. Supporting evidence for all the claims should be scanned and mailed along with the CV.

5. No claim will be entertained without proper supporting documents.
6. Merely fulfilling the minimum qualifications or the eligibility criteria does not entitle an applicant to be necessarily considered for the engagement to the post or shortlisted for the online interaction. The University may restrict the number of applicants to be called for interaction on the recommendations of the short listing/screening committee,





constituted by the Competent Authority.

7. Canvassing in any form will be treated as a disqualification.
8. All engagements shall be made provisionally subject to verification of certificates and antecedents of the applicant at the time of interaction / engagement or at any stage during the period of teaching. In case, it is found at any point of time that any document/information submitted by the applicant is false or the applicant has suppressed any relevant information, the engagement shall be withdrawn forthwith without assigning any reason.
9. All the correspondence from the University including interaction communication, if any, shall be sent only to the mail address provided by the applicant in their application form. The applicants are advised to check the website of the University regularly for updates.
10. Any addendum/ corrigendum, if any, shall be posted on the website of the university [www.cuap.ac.in](http://www.cuap.ac.in)
11. The University reserves the right to revise/reschedule/cancel/suspend/withdraw the engagement process in part or full without assigning any reason. The decision of the University shall be binding and no appeal in this regard shall be entertained.

## UNIVERSITY GRANTS COMMISSION NOTIFICATION

New Delhi, the 11th October, 2021

**No. F.9-1/2010(PS/MISC)Pt. Vol.I.**—In exercise of the powers conferred under clause (e) and (g) of sub-section (1) of section 26 read with section 14 of the University Grants Commission Act, 1956 (3 of 1956), the University Grants Commission hereby makes the following amendment in the University Grants Commission (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) Regulations, 2018, namely:-

1. **Short title and commencement.**—(1) These regulations may be called the **University Grants Commission (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) Amendment Regulations, 2021.**
  - (2) They shall come into force on the date of their publication in the Official Gazette.
  2. In the University Grants Commission (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) Regulations, 2018, in regulation 3, for sub-regulation 3.10, the following sub-regulation shall be substituted, namely:-
- 3.10 “The Ph.D. Degree shall be a mandatory qualification for direct recruitment to the post of Assistant Professor in Departments of the Universities with effect from 01.07.2023.”

**Subject: Revised guidelines for enhancement of the Rates of Honorarium of Guest Faculty.**

Madam/Sir,

The Commission in its 537<sup>th</sup> meeting held on 10<sup>th</sup> December, 2018 considered the issue of enhancement of the rates of Honorarium of Guest Faculty in universities and colleges consequent upon the implementation of the recommendations of the 7<sup>th</sup> Pay Commission and resolved as follows :

1. The Honorarium for Guest Faculty be enhanced to Rs.1500/- per lecture subject to a maximum of Rs.50,000/- per month.
2. The Guest Faculty be appointed only against sanctioned post. However, for the universities where the sanctioned posts are not adequate as per the teaching working load, the number of Guest Faculty to be appointed can be up to 20% over and above the sanctioned posts.
3. The qualification for Guest Faculty shall be the same as those prescribed for the regular Assistant Professors of Universities/Colleges in UGC Regulations.
4. The Selection procedure for appointing Guest Faculty shall be the same as those of regularly appointed Assistant Professors. However, the composition of the Selection Committee shall be as follows:
  - (i) The Vice-Chancellor or his/her nominee shall be the Chairperson of the Selection Committee
  - (ii) One expert in the concerned subject nominated by the Vice-chancellor.
  - (iii) Dean of the concerned Faculty; wherever applicable
  - (iv) Head/Chairperson of the Department/School

- (v) An academican representing SC/ST/OBC/Minority/Women/Differently-abled categories to be nominated by the Vice-Chancellor or Acting Vice-Chancellor, if any of the candidates representing these categories is the applicant and if any of the above members of the Selection Committee does not belong to that category.


At least four members, including one outside subject expert shall constitute the quorum.

5. Guest Faculty will not be treated like regular teachers for the purpose of voting rights or for becoming the members of the various statutory bodies of the university.
6. The superannuated teachers may also be considered for engagement as Guest Faculty subject to a maximum age limit of 70 years.
7. The Guest Faculty will not be given the benefit of allowances, pension, gratuity and leave etc. as admissible to the regular teachers.

**These guidelines will come into force with effect from the date of issue of this letter.**

The contents of the letter may be brought to the notice of the affiliated colleges/institutions also.
