SECTION 1

Central University of Andhra Pradesh, Ananthapuramu is a newly established university under the act of Parliament (15 of 2019) in the state of Andhra Pradesh. Central University of Andhra Pradesh, Anantapur was established in 2018. It is one of the leading universities in Arts Humanities and Social Sciences, Management Studies and Vocational Studies. It is governed by the regulations of Central Universities Act 2009, UGC and Ministry of Education. More than 13 courses are taught in this institution at present. Additional 12 Schools will be started in phased manner.

Thus, Central University of Andhra Pradesh proposes to Establish IT Infrastructure by designing a Smart Campus Network solution which is ahead by at least 10 Years and takes care of all changes happening in the industry. Today's network is a strategic instrument that must be accessible anytime from anywhere simultaneously offering fast, secure, reliable services at scale regardless of location.

The Campus infrastructure solution should be designed on the latest Topology with 10G/40G/100G Backbone taking capacity across the Campus. The 10/40G backbone is between the Distribution Switch and the Core and all Edges are based on legacy based 10/1000 Mbps. The Network design should provide reliable performance when new applications like – Video Conference, VoIP, e-Classroom is required to be installed and used. Further in today's highly Volatile Network requirements wherein there are so many users in a Campus – Laptop, Desktop, Smart Phones, iPads, iPods etc., wherein the User's today are required to use this infra- structure for Video, Voice and various collaborative applications require a high performing, Scalable, Secure wired and wireless infra-structure.

WHO CAN APPLY

Those Central/ State Public Sector Units (PSUs) / IT Consultants registered in India, who possess relevant eligibility as per eligibility criteria for providing PMC services can apply as a sole bidder. No bids shall be acceptable in consortium of companies/individuals.

Bidder should take into account notifications, corrigendum published, if any on the EOI document before submitting their bids.


Bidder should go through all EOI documents carefully and must understand the documents required to be submitted as part of the bid. Any deviations from these may lead to rejection of the bid.

Response to EOI

The Response to the EOI should specify following:

Relevant Documents as sought according to Eligibility Criteria

- 1.1. Relevant educational and work experience related certificates
- 1.2. Tentative Budgetary Cost for overall service excluding GST



Technical Proposal

- 1.3. Detailed Writeup for proposed Methodology for designing, planning, implementing, operating, maintaining and supporting the said project along with necessary architectural design and drawing.
- 1.4. Tentative Bill of Material (BoM) including summary of active and passive component
- 1.5. Proposal should include High level technical details of proposed Hardware / Software like Wi-Fi Controller, Wi-Fi Access Points, Wi-Fi management software, other related infrastructure etc.
- 1.6. Proposed approach for implementation plan along with necessary architectural diagram proposed time frame for execution of the complete project.

NOTE: All documents submitted by the bidder(s) in their bid proposals shall become the property of the Institute and may be used without making any reference to the bidders

Validity of EOI

The proposal must be valid for a period of at least 90 days from the date of submission. It shall be assumed so, in case it is not explicitly mentioned in the proposal. Proposals will be summarily rejected if they are not valid for at least 90 days.



SECTION - II

The site and network zoning

The project for setting up of ICT Infrastructure at CUAP Ananthapuramu campus has the singular focus of setting up an integrated state-of-an-art facility for managing and sharing digital information. The expectation is for the project to be planned with utmost considerations including checking the failsafe configurations, data restore features and keeping the system up for 24*7*365(99.97%).

Network is to be designed using latest technological trends and is proposed to have a High Speed Backbone, Redundancy in Active-Active Mode, enhance security and Scalability, Centralised management and end to end encrypted traffic, Network service automation, ability to support star, ring, mesh, partial mesh topology connectivity without any complex configuration. The network design should be flexible, simple and expandable for both wired and wireless infrastructure.

Scope of Work/ Services

Central University of Andhra Pradesh Ananthapuramu has a vision of it being a state-of-the art Smart campus with all modern amenities and facilities. Given the advent of Internet of Things and increased dependence on digital technologies in our day-to-day life, data and communication networks and associated services are now an absolute necessity for a campus.

The PMC shall provide project management consultancy services to CUAP Ananthapuramu for setting up the Smart Campus Wide Network, procurement of IT devices and other ICT services for academic, administrative, hostels.

 - 3.2. Attendance management system
 - 3.3. Administration process automation
 - 3.4. Student smart ID card management

Minimum criteria for eligibility

The bidder who fulfils the following requirements shall be eligible to apply. Central Govt. Organizations / PSUs /IT Consultants should have completed / ongoing Project Management Consultancy services for ICT based infrastructure setup (and it must include the supervision, quality control, billing including installation and commissioning) of magnitude as below, during the last five years ending previous day of last month of submission of EOI:

One consultancy assignment of 80% value of the tentative project cost of Rs. 10 Cr for similar ICT based infrastructure setup.

Two consultancy assignments of 50% value of the tentative project cost of Rs. 10 Cr for similar ICT based infrastructure setup.

"Similar setup" in these criteria means Project Management Consultancy for setting up Network and ICT infrastructure for academic campuses, centrally funded institutes and R&D institutes or organizations of similar nature.

The bidder must provide the following documents:

- 1. A copy of incorporation certificate of the bidder as proof of registration in India.
- 2. Annual audited financial statements for the last three financial years (i.e. FY20- 21, FY21-22, FY22-23).
- 3. List of eligible similar nature successfully completed/ongoing works during last five years and duly certified by the clients.
- 4. Particulars of works/projects and performance of the bidder duly authenticated certified by the client should be furnished separately for each work.
- 5. The Bidder should have a client base of minimum 50 Major clients or above.
- 6. Bidder/ Company should have an RCDD+ PMP Certified resource on board.
- 7. Bidder/Company should have clients from IT/ITES, R&D labs, manufacturing companies, warehouses, data centers, telecom.
- 8. Bidder/Company should have CCIE (written) certified CCDP on board and 3+ IGBC certified professionals.

A technical write-up comprising the high-level plan to be adopted by the PMC covering the following points:

- 1. An overall write-up (as a concept note) setting out the implementation philosophy to be adopted for carrying out the work for CUAP Ananthapuramu.
- 2. Provide a high-level project management plan.

EVALUATION CRITERIA

The details submitted by the bidder will be evaluated based on the eligibility and Presentation (in percentage 60:40 respectively) quoted for the assigned job/work by the CUAP Ananthapuramu. The price quoted should be in Indian currency.

Even if a bidder satisfies the above requirements, bidder may be disqualified if the bidder has made misleading or false representation or deliberately suppressed the information in the forms, statements and enclosures required in the eligibility criteria documents, record of poor performance such as abandoning work, not properly completing the contract, financial failures/weaknesses, or inadequate deployment of resources etc.

The selected bidder will be required to sign the Contract agreement within 5 working days of the issue of such letter. CUAP Ananthapuramu may assign the job/work in parts to the selected bidder/PMC on a time-to-time basis as per the requirement of CUAP.

Validity of the Assignment

Three years from the date of signing the agreement, extendable for another one year.

Terms and Conditions

i. CUAP Anantapuramu reserves the right to accept or reject any or all EOI, at any time without assigning any reason.

The tendered rates should be valid for a minimum period of 90 days. ii.

Settlement of any disputes in Ananthapuramu Courts - Vice Chancellor, CUAP iii. Ananthapuramu or his/her authorized representative shall be the final authority in all disputes and decision will be accepted to all concerned.

The two-bid system shall be followed for this EOI. In this system, the offer should be submitted iv. under two-bid system in two separate envelopes posted in one cover. The two envelops should clearly be superscribed technical bid and financial bid. Technical Bid must not include any commercials being offered directly or indirectly. Failure to do so shall reject the bid summarily. financial Bid must contain only the financial proposal. Any technical sections attached in the financial bid will be ignored. Any conflict between the information provided in the Technical Bid and financial Bid, the Institute will have the right to take the best option to resolve the conflict while ignoring the other.
