5.	Three Persons nominated by the Visitor	i. Joint Secretary and Finance Advisor, MHRD, or his/her nominee from Finance Bureau of MHRD not below the rank of Deputy Secretary ii. Joint Secretary (CU&L) of MHRD, or his/her nominee not below the rank of Joint Secretary of Govt. of India iii. Joint Secretary (CU), UGC or any other Joint Secretary level Officer nominated by the Chairman, UGC (<i>Dr. J.K Tripathi, Joint Secretary, UGC, New Delhi nominated by the Chairman, UGC</i>).
6.	The Finance Officer, Central University of Andhra Pradesh	Shri. Vijay Kant, Assistant Registrar (Accounts), Ex-Officio Secretary i/c.

All the members of the Finance Committee, other than ex-officio members, shall hold office for a term of three years. The Finance Committee shall meet at least thrice every year to examine the accounts and to scrutinize the proposals of expenditure. Five members of the Finance Committee shall form a quorum for a meeting of the Finance Committee.
